**TURNING POINT DANCE STUDIO LLC RULES** - Please be on time - No gum, candy or drink in the studio - Street shoes are not permitted on the dance floor or mat - No observer/visitors - Fees are due by the 7<sup>th</sup> of the month for the discount rate. All fees are listed in the monthly newslines, please read carefully.

\_\_\_\_\_ **Discount Rate Tuition is Due by the 7th of the month.** Regular Rate begins the 8th - 20th. Late Fee's will be assessed the 21st. \$5.00 per class enrolled in. Tuition is the same whether it's a long (5 week) or short (3 week) month.

\_\_\_\_\_ There is a **30 day cancellation process** that will begin from the date that the Drop Card is received by the studio. Drop Cards are available at the office window or requested by email. Please include the dancers name and class you wish to drop. Phone calls & emails are not acceptable (the forms must be filled out and signed). 30 days from the date received the dancer will be officially removed from the billing system. All fees accrued within those 30 days must be paid. This does not apply to Performing Team, since all members have contracted and committed for the entire year.

\_\_\_\_\_ **Costume Deposit(s) of \$45 per costume (teams \$55 per routine) is due September 3rd** with remaining balance due in October. They must be ordered on time because we use them for our December Recital. Your dancer will use the same costume for the May recital. We also take most dancers to one competition (excluding the 3 yr olds.), so you definitely get your money's worth!

\_\_\_\_\_ **Performing Team is an annual commitment - June through June.** Tuition will be charged along with an early termination fee if cancelled before June. All classes are to be paid for in Advance. Collection fees will be the signers responsibility, if that process becomes necessary. **Teams- note that we will be really busy March to May practicing, performing and competing. Please don't get involved in activities that will conflict with team commitments during this time. If you choose miss a competition, you will be charged for formation changes per routine. Dress Rehearsals are mandatory and usually held on Mondays and/or Thursdays. Dancers are required to be to all classes & rehearsals two weeks prior to each competition.**

\_\_\_\_\_ **Proper Dance Attire is required.** Tights, leotard, dance shorts or pants, and dance tops are acceptable. No baggy sweat pants or loose clothing. Hair is to be pulled back out of the face. Shoes should be worn each week to class.

\_\_\_\_\_ **I do understand that dance is a very physically exacting discipline and that the Turning Point Dance Studio LLC will do all in their power to ensure the proper training and safety of each student.** Because of the physical demands dance/tumbling places on the body, sometimes injuries do occur; therefore I hereby release Turning Point Dance Studio LLC, it's owners, employees/contractors/operators from any and all liability, that may result from dance/tumbling related injuries -as well as any claims, demands, and causes of action whatsoever, arising out of or related to any loss, damage, or injury, including death, that may be sustained by the participants and/or the undersigned, while in or upon the premises or any premises under the control and supervision of Turning Point Dance Studio LLC, its owners and operators or in route to or from any of said premises.
